II. Review/Finalize/Vote on Charter: Chair Martinis thanked the citizen who again came out to discuss this charter. He is asking the committee to review and then vote to move the amended charter to the town meeting. The one area of continued discussion is the Town Administrator Residency Requirement. There has been quite a bit of discussion on this issue. The Chair recommends that we stay with removing this requirement as was previously discussed for the past year. The select board and the committee can continue to insist that they be extremely active in town.

Mr. Sposato would feel more comfortable to amend the language to say, "residency preferred but not required."

Mr. O'Connell: Would rather leave the wording as is and allow the select board to waive the requirement.

Roll call vote to remove the residency requirement follows: 6/2 in favor with J. Altomonte and W. O'Connell voting no.

Mr. Sposato wanted to continue the discussion about making sure that the two ad hoc members to the committee for the future. After much discussion of the board the recommended the language change suggestion would be: "preference be given to residence who do not hold an elected position."

Motion made by L. Sposato to accept these changes as presented. Unanimous 8-0 via roll call.

Mr. Martinis made a motion to move the charter to the town meeting to be presented ahead to the citizens on 10/30. Second by S. Garten. Roll call vote: 6-2 in favor with W. O'Connell and J. Altomonte voting no.
